FEBRUARY MEMBERSHIP MEETING (22 FEB)

Public Safety/Law and Order (PS/L&O)

The Colorado Springs (COS), Colorado Chapter of MOWW was honored to welcome Ms. Kristin Hersh, from the Human Trafficking Task Force of Southern Colorado as our guest speaker during our 22 February 2025 Companion Meeting. Ms. Hersh provided an excellent presentation on the causes, signs and actions to prevent human trafficking. Based in Colorado Springs, the Task Force is a 501(c)3 Non-Profit corporation that provides education and ideas for preventing human trafficking. Ms. Hersh explained the breadth of human trafficking in such diverse areas as: hospitality, construction, agriculture, forced labor, as well as the more well-known areas of sex trafficking. She noted that while labor trafficking is more prevalent, sex trafficking is more lucrative. 40 million people are estimated to be involved in human trafficking worldwide. Her presentation also included steps that we can all take to prevent and report suspicious situations that may indicate human trafficking is taking place. We thank Ms. Hersh for her service to Southern Colorado and her efforts to combat human trafficking in our community. The



mission of the Human Trafficking Task Force of Southern Colorado is to build a collaboration of organizations and individuals to reduce human suffering caused by human trafficking, through advocacy, awareness, rehabilitation, and services for survivors.

MARCH MEMBERSHIP MEETING (22 Mar)

National Security

The guest speaker for this month's meeting is Colonel Mark Cobos Commander of the 1st Space Brigade, the only brigade in the Army dedicated to fighting from, through, and into space. He was born and raised in El Paso, Texas and graduated from West Point in 2000. He has led troops at every level from platoon to brigade,



including deployments to Bosnia, Iraq (x3), and Afghanistan.

His command experience includes the 1st Space Battalion from 2019-2020 and a Sapper company in the 3rd Infantry Division while deployed to western Iraq for 15 months from 2007-2008. His 200-strong company team of Soldiers and Marines fought an insurgency in the cities of Hit and Rutbah, and from the Euphrates River Valley to the Syrian border while mentoring city councils, mayors, service departments, police forces, and tribal councils at the heart of the Anbar Awakening—the movement credited with turning the tide of the war in Iraq. He also commanded an Army firefighting detachment during Operation Iraqi Freedom in 2003-2004, and led Sapper platoons in the 10th Mountain Division in 2001-2003.

Colonel Cobos served on the Joint Staff from 2016-2019, where he helped lead efforts to establish the United States Space Command between the Pentagon, the White House, and the Congressional Armed Services Committees. He also led Joint Staff contributions to the space-related initiatives and strategies of the National Security Council, the National Space Council, and the Office of the Undersecretary of Defense for Policy. He contributed to the writing of the National Security Strategy, the National Space Strategy, the National Defense Strategy, and the National Military Strategy, and was recognized by the Chairman of the Joint Chiefs of Staff as the 2018 Joint Staff Officer of the Year.

His assignments as a colonel include Deputy Commander of the Joint Functional Component Command for Integrated Missile Defense and the J35 at U.S. Space Command. Other staff assignments include Army space experiments and wargames branch chief, where he assisted in the initial experimentation of the National Space Defense Center; aide-de-camp to the Commanding General, U.S. Army Space and Missile Defense Command; and campaign planner for Pakistan/Afghanistan coordination and the transition to Operation Resolute Support at Headquarters, International Security Assistance Force, in Kabul, Afghanistan.

Colonel Cobos holds a Bachelor of Science from the United States Military Academy-West Point (international relations), a Master of Science from the University of Missouri-Rolla (geology and geophysics), a Master of Military Arts and Science from the Army's School of Advanced Military Studies, and a Master of Science from the National War College (national security strategy, Distinguished Graduate).

NATIONAL SECURITY (NS)

(Executive Summary from Defense Space Strategy Summary June 2020)

The Department of Defense (DoD) is embarking on the most significant transformation in the history of the U.S. national security space program. Space is now a distinct warfighting domain, demanding enterprise-wide changes to policies, strategies, operations, investments, capabilities, and expertise for a new strategic environment. This strategy identifies how DoD will advance spacepower to enable the Department to compete, deter, and win in a complex security environment characterized by great power competition.

Space is vital to our Nation's security, prosperity, and scientific achievement. Space-based capabilities are integral to modern life in the United States and around the world and are an indispensable component of U.S. military power. Ensuring the availability of these capabilities is fundamental to establishing and maintaining military superiority across all domains and to advancing U.S. and global security and economic prosperity. Space, however, is not a sanctuary from attack and space systems are potential targets at all levels of conflict. In particular, China and Russia present the greatest strategic threat due to their development, testing, and deployment of counterspace capabilities and their associated military doctrine for employment in conflict extending to space. China and Russia each have weaponized space as a means to reduce U.S. and allied military effectiveness and challenge our freedom of operation in space.

Rapid increases in commercial and international space activities worldwide add to the complexity of the space environment. Commercial space activities provide national and homeland security benefits with new technologies and

services and create new economic opportunities in established and emerging markets. The same activities, however, also create challenges in protecting critical technology, ensuring operational security, and maintaining strategic advantages. Internationally, allies and partners also recognize the benefits of space for military operations, and increasingly understand the threats to those space activities.

Allies and partners who are actively expanding their defense space programs, present novel opportunities to increase defense collaboration and cooperation. In response to this new security environment, and in accordance with the 2018 National Strategy for Space and the 2018 National Defense Strategy, this Defense Space Strategy provides guidance to DoD for achieving desired conditions in space over the next 10 years. The DoD desires a secure, stable, and accessible space domain, whose use by the United States and our allies and partners is underpinned by comprehensive, sustained military strength. The strategy includes a phased approach for the defense enterprise to move with purpose and speed across four lines of effort: (1) build a comprehensive military advantage in space; (2) integrate space into national, joint, and combined operations; (3) shape the strategic environment; and (4) cooperate with allies, partners, industry, and other U.S. Government departments and agencies.

The Department is taking innovative and bold actions to ensure space superiority and to secure the Nation's vital interests in space now and in the future. Establishing the U.S. Space Force (USSF) as the newest branch of our Armed Forces and the U.S. Space Command (USSPACECOM) as a unified combatant command, as well as undertaking significant space acquisition reform across the DoD, has set a strategic path to expand spacepower for the Nation. It is a path that embraces space as a unique domain of national military power that, together with the other domains, underpins multi-domain joint and combined military operations to advance national security. HOMELAND SECURITY

Department of Homeland Security (DHS) Space Policy

Within the homeland security enterprise, space-based systems play a critical role in securing the homeland as DHS components and partners rely heavily on space systems to provide information and communications necessary for mission success. The DHS Space Policy guides component efforts internally and across the homeland security enterprise.

DHS Policy

A) Support the security, integrity, and resilience of government and private sector space-based systems and their associated supply chains during their design, development, acquisition, deployment, and operation. Space systems enable key functions such as global communications; positioning, navigation,

and timing; scientific observation; exploration; climate monitoring; and multiple vital national security applications. Therefore, it is essential to assess and communicate risks to space systems to enable protection from cyber or other threats, including manipulation and unauthorized access to prevent disruptions to delivery of critical services and data. DHS will advocate for the incorporation of cybersecurity principles for all phases of space systems design, development, acquisition, deployment, and operation across the industry. DHS will maintain closer relationships with its diverse government and industry partners to focus on cybersecurity measures for space systems and will develop best practices, education materials, and standards consistent with Space Policy Directive-5 (SPD-5), Cybersecurity Principles for Space Systems.

B) Build resilience into the use of critical space assets to minimize the impact of any natural or human-made disruptions on the homeland and to DHS mission execution. Therefore, DHS will prioritize engagement with federal interagency partners and the private sector to increase assurance and fortify the resilience of space-enabled components of NEFs and NCFs against natural or purposeful interference and harmful manipulation, through encouraging the fielding, exercising, and employment of secure and resilient materiel, and non-materiel, space, and non-space capabilities. In addition, DHS will hold periodic operationally focused exercises to test the continuity of NCFs and Primary Mission Essential Functions and associated systems in a degraded or denied space environment as a result of natural or human-made disruptions. Components will develop procedures and continuity plans for the loss of critical space systems and conduct internal exercises focusing on such an event. Components will develop continuity plans that consider alternatives to their space-based systems to increase the Department's resilience to the loss of space systems.

C) Develop contingency plans for a degraded space environment, regardless of cause. In addition to impacts of space weather and other natural causes, DHS must prepare for the potential that heightened tensions or adversarial activities in space may lead to impacts upon domestic space assets. Accordingly, DHS will develop contingency plans consistent with its mission to plan for potential impacts to the homeland and manage associated national response and recovery efforts consistent with DHS authorities. Components will incorporate into contingency plans any potential vulnerabilities, likely targets, and mitigation measures that may be unique to adversarial military actions in the space domain. DHS

will participate in and otherwise support interagency and international discussions around norms and responsible state behaviors for space and in response to activities in space.

PUBLIC SAFETY/LAW & ORDER (PS/L&O)

Space resources and technology are used to support law enforcement in a variety of ways, including intelligence gathering, crime detection, and disaster response.

- Intelligence gathering: The US intelligence community uses space assets to support military and law enforcement operations
- Crime detection: Artificial Intelligence-powered image and video processing tools can detect objects like weapons and identify subjects of interest. Drones can be used to monitor crowds, but may be invasive.
- Disaster response: Space-based solutions can help with disaster relief and recovery
- Civil security: Space-based solutions can help with civil security and crisis events, such as humanitarian responses, law enforcement, and safety.

VETERANS AFFAIRS

On December 12, 2024 President Biden signed into law H.R. 1432, the “Veteran Service Organization (VSO) Equal Tax Treatment Act” or the “VETT Act,” which amends the Internal Revenue Code of 1986 to provide for the deductibility of charitable

contributions to certain organizations for members of the Armed Forces.

The MOWW is one of the organizations that will benefit from this new law.
