The Order elected LTC John H. Hollywood, USA (Ret), as the Military Order's 88th Commander-in-Chief (CINC)





### CINC LTC JOHN H. HOLLYWOOD, USA (RET)

CINC LTC Hollywood was commissioned in the Regular Army in 1968, following graduation from California State Polytechnic University, San Luis Obispo, CA. During his career he had assignments with the 82nd Airborne and 1st Infantry Divisions, several intelligence organizations, including one in Berlin, Germany, that resulted in the arrest of an East German agent trying to recruit American military personnel for the Soviet Union. He also served with the Army Recruiting Command and taught at two Army service schools. After his retirement he worked in the financial services industry, ending as the Managing Partner of Rosenzweig, Hollywood & McDowell, a financial services firm in Bethesda, MD. He is currently an Adjunct Associate Professor at University of Maryland University College. In the Military Order of the World Wars, he has served as a VCINC, Treasurer General, General Staff Officer, (elected); Senior Vice Commander Region IV, Department of Maryland Commander, Commander of the GEN Meade Chapter. He has a Master's Degree in Sociology from the University of Arizona and an MBA from Northwestern University. ★



### SVCINC LTC CHARLES S. CHAMBERLIN, USA (RET)

SVCINC LTC Chamberlin is a 1960 Texas A&M Distinguished Military Graduate, receiving a BS degree in Industrial Engineering. He also holds a Master of Business Administration degree (Fairleigh Dickinson University). His 20 years of US Army service included: 101st Abn Div; 10th SFG (Abn) (Co Cmdr); 5th SFG (Abn) (Vietnam); Career Course Distinguished Graduate; USMA Tactical Off; USAFA Army Exchange Officer; MACV J-6 (Vietnam); 9th Inf Div (Battalion XO); Army C&GS College; NMCC JCS (Pentagon), Emergency Action Officer; 2nd Inf Div (Battalion Cmdr) and The Defense Communications Agency as Implementation Branch Chief. He wears the Combat Infantryman Badge, Ranger Tab, Master Jump Wings, German and Vietnamese Jump Wings, and the JCS Badge. After his 1981 Army retirement, he was a telecommunications executive for 28 years (14 years as a corporate vice president). He joined MOWW in 2004, serving as the Dallas Chapter's Junior Vice Commander and Chapter Commander, and as the Region VIII Commander. He was the Chair, Council of Area Commanders, and served on the EXCOM. He is an Outstanding Service Award, Silver and Gold Patrick Henry Medal recipient. ★



### VCINC BGEN FREDERICK R. LOPEZ, USMCR (RET)

VCINC BGen Lopez served 31 years on active duty and in the United States Marine Corps Reserve. His tours of duty include 13 months in Vietnam (1968-1969), including duty as a Rifle Platoon Commander (Vietnam) and Sniper Platoon Commander (Vietnam), Company Commander, S-3 Operations Officer, Infantry Battalion Commander, Assistant Division Commander, Commanding General 4th Marine Division, and Deputy Commanding General 1st Marine Expeditionary Force. Medals and decorations include the Distinguished Service Medal, the Bronze Star Medal with Combat "V," the Navy Commendation Medal, the Combat Action Ribbon and numerous other decorations and badges, including the Navy & Marine Corps Parachutist Wings. He holds a BS (Mathematics) from California Polytechnic (San Luis Obispo) and an MS (Computer Science) from West Coast University. He retired from Raytheon Company in 2007 as a Director of Engineering, Electronic Warfare Systems. He has been a Companion in MOWW for 19 years, holding command positions at the chapter, department and region levels, General Staff Officer (Elected), and his current position as Vice Commander-in-Chief. ★





**VCINC CDR ROBERT F.  
HARTMAN III, USN (RET)**

VCINC CDR Hartman graduated from the US Naval Academy in 1969. Until 1974, he was on active duty as a Surface Warfare Officer, serving on destroyers and minesweepers, and in a research and development project (Surface Effect Ships). In 1974, he transferred to the Naval Reserve as an Active Reservist (1974-1989) in units supporting the Military Sealift Command, the Chief of Naval Operations and the Commander, Atlantic Fleet. In 1975, he earned a BA in Accounting (University of South Florida), became a CPA in 1977 and worked in public accounting until 1979. He then was the Vice President of Accounting, later Chief Financial Officer, of a Navy contractor. He retired in 2007. During this time, he earned an MBA. (George Washington University) and completed the Naval Command & Staff Program. He formed his own company in 2009 preparing individual and small business tax returns. He is active in the local Chamber of Commerce, Rotary and other community organizations. In 2010, CDR Hartman became a Perpetual Member of MOWW and joined the Gen Meade Chapter. He has served as Chapter Treasurer, Chapter Commander and Director of the National Capital Area YLC, and Treasurer General of the Order. ★



**VCINC MAJ ROBERT J.  
WILLIAMS, USAF (RET)**

VCINC Maj Williams was commissioned by the United States Air Force in 1969. He wears the Master Aircraft Maintenance Badge and has served as an aircraft maintenance officer at Ellsworth AFB, U-Tapao Airfield, Offutt AFB, Chanute AFB; RAF Mildenhall and Minot AFB. Retiring in 1988, he next spent 24 years with FlightSafety International as an Instructional Developer and Project Specialist, retiring again in 2014. As a Companion, he was the Fort Worth Chapter Junior Vice, Senior Vice and Chapter Commander. He was also the Chair, Scouting Committee, a General Staff Officer, an appointed EXCOM member, and the Adjutant/Treasurer and Commander, Region VIII. He is a recipient of MOWW's Gold and Silver Patrick Henry Medals, Outstanding Service Medal, Outreach Service Medal, Membership Medal with bronze hour glass, James E. She was the Volunteer Coordinator, West Texas Medical Reserve Corps (2006-2014), and Chair, El Paso Voluntary Organizations Active in Disasters (VOAD), from 2013-2015. # REMARKS TO 2018 MOWW CONVENTION

“GEN McCaffrey, general and flag officers, Past Commanders in Chief, Commanders, Companions and honored guests, welcome to the start of the 100th year of the Military Order of the World Wars.

Before I share some thoughts, I want to publicly thank Colonel Dave Gibson for the super job he did as

CINC this past year. He is an inspiring leader who worked diligently to improve the Order. As in all things, he was helped immensely by his wife, Diane. So, my thanks to you both of you for a job well done.

When I was a lieutenant, one of the first things I had to do was join the Officer’s Club. The units I belonged to used the club for happy hours, events like dining-ins, promotion parties and special events. The club was a place where you could talk to your boss in an informal atmosphere along with other members of the command.

Now, officer, NCO and enlisted clubs have gone away. Younger officers never had an officer’s club to go to and I’ve been surprised to learn that some recent retirees also didn’t have that experience. I bring this up because in my mind MOWW is a unique organization. We are, in fact, a place where military officers can feel at home, where we have similar values, have been to many of the same places and done many of the same things.

Let me tell you how I joined the Order. I went to the “dark side” and was running for the Maryland House of Delegates. At a “meet and greet,” Past CINC

LTC Alfred Shehab asked me to join MOWW. I knew about the Order since I saw the flag in the officer’s club when I was on active duty. However, I wasn’t really interested since I was a Vietnam Veteran and not a World War II one. MOWW membership was \$40 bucks and I said, “OK, I’ll join.”

When I went to my first chapter meeting, Joanne and I were welcomed and shown to a table with other Companions that PCINC Shehab thought we’d like. This occurred the first few times we went. I felt very comfortable since we had similar backgrounds, where folks actually welcomed you and knew your name. Then, I was encouraged to participate in chapter activities, starting with a Massing of the Colors, and then becoming a Junior Vice Commander. I went to my first convention, here in Columbus, GA, and as the saying goes, the rest is history.

I tell this story for a couple of reasons. First, someone asked me to join the Order. If they hadn’t, I wouldn’t be here. I’m not aware of anyone who showed up at a chapter meeting out of the blue and said, “I want to join MOWW!” Second, I was welcomed when I went to chapter meetings. Those meetings had interesting speakers and I enjoyed the experience. Third, I was given a job and moved up the chapter leadership ladder. Fourth, I was mentored in what the Order was, how it functioned and how it served others. I was given opportunities to grow. If not, I probably would have just been a “social member” of MOWW.

Not everyone is a recruiter, but it is helpful to be able to explain what the Order is and what it does. The follow-up is to make sure that the potential Companion is made to feel welcome when they come to meetings. Prior to a Companion installation ceremony, I recommend that a brief biography of the new Companion be read. That way, chapter Companions know more about the new member. Once a new Companion joins the chapter, make

sure he or she has a job to do—even if it is as a Third Assistant Junior Vice Commander. Also have interesting meetings and guest speakers.

This is how the Strategic Goals supported my involvement and growth in the Order.

- The first Strategic Goal, Recruiting, Involvement and Retention, got me in the door.
- I participated in the Massing of the Colors and then YLCs, and that was the second Strategic Goal, Outreach.
- As I grew in the Order, I got involved with trying to get publicity for my chapter, our third Strategic Goal.
- This was followed by training Companions and leadership teams so they knew what to expect and how to fill the roles required of them in the Order, the fourth Strategic Goal.
- Finally, to the fifth Strategic Goal, we should recognize excellence in fellow Companions, chapters and our local communities.

I'm no different than any other Companion who joins the Order. Each Companion is looking for something, and if you are careful with the care and feeding of new Companions, they will grow into assets for the Order and the nation.

The Chinese proverb says, "Many hands make light work." I can't do it alone. I need your help so the Order continues as a successful, vibrant organization.

So, here is what I will ask of you as my fellow Companions. We have an annual membership goal of four percent. However, some chapters haven't recruited anyone. For the 100th year of the Order, I'm asking all chapters to recruit and track their progress at each chapter meeting so they at least achieve that four percent goal. Then, once new folks are recruited, involve and mentor them.

One more thought on mentoring, when I visit chapters or regions, please introduce me to Companions you feel should be identified as future leaders of the Order. They are the future. We need quality folks to replace all of us. We tell Perpetual Members that the Order will never forget you. But, if there is no Order, that's hard to do.

Since we are starting our 100th year, I strongly urge all of you to attend the 2019 National Convention in California. It will definitely be an event to remember. I look forward to seeing all of you there. Let's work together so future Companions can celebrate the Order's 200th year." ★

## PRE-CONVENTION (6-8 August 2018)

Convention-related festivities kicked off as they always do with the 6 August MOWW Golf Tourney. This year it was held at the beautiful Green Island Country Club, which is nestled amongst the beautiful pine forests overlooking the serene waters of Lake Oliver. These avid golfers were later feted on 9 August during the much-enjoyed CINC Welcome Buffet.

Tuesday, 7 August, was a day of business. Not only was the traditional Pre-Convention EXCOM held, but the day also featured sessions of the MOWW, Inc., Board of Trustees, the Council of Area Commanders and the Patriotic Education, Inc., organization. Later that night the law firm of Pope, McGlamry, Kilpatrick, Morrison & Norwood hosted EXCOM members and their spouses and partners for cocktails and hors d'oeuvres in their offices. Their offices are located in the old Columbus Union Station, built in 1901, which once served the Central of Georgia and Southern Railway. Our then-JAG, COL Earle Lasseter, a member of that firm, made the excellent arrangements.

Wednesday, 8 August, continued the happy tradition of the “All Hands Tour” day, which featured visits to the widely-praised National Infantry Museum and the National Civil War Museum. The late afternoon featured two sessions: the annual Hann-Buswell Chapter (At-Large) meeting and the National Officer Candidate

Meeting. The day ended with Companions spending time in the city of Columbus, visiting shops, sightseeing and enjoying dinner at the many fine eating establishments.

## CONVENTION (9-11 August 2018)

Thursday, 9 August, marked the beginning of the convention proper and was focused on convention workshops. These involved multiple sessions on recruiting and increasing Companion involvement to achieve MOWW’s Strategic Goal 1, chapter leadership and management best practices, and Internal Revenue Service filings. The workshops culminated with attendees developing actual Chapter Action Plans, which were to be implemented by all chapters post-convention to achieve MOWW’s five Strategic Goals.

Following the CINC’s Workshop Wrap-Up, conferees adjourned and later reassembled that evening for the annual CINC Welcome Buffet—which began with welcoming remarks from then-CINC Col Dave Gibson. Next were LTC Mike Wilgen’s inimitable MOWW Golf Tourney award presentations, delicious food, the terrific Fort Benning Army Band, and wonderful companionship throughout the evening.

On Friday, 10 August, the day’s convention events began with the annual Past Commanders-in-Chief (PCINC) Working Breakfast, which had two parts. The first part involved the PCINCs meeting with



then-CINC Col Gibson, then-CINC candidate and SVCINC LTC John Hollywood, and Brig Gen Art Morrill, the Order's Chief of Staff, for discussions on the state of the Order and future plans. After these three National Officers left, the PCINCs went into executive session, deliberating on matters concerning the good of the Order.

The next activity involved national candidate presentations, during which candidates were nominated, which were followed by presentations by the candidates themselves. Next was national delegate voting; the results of that election are reflected elsewhere in this issue and in the MOWW National Directory, which is available on the MOWW website ([www.moww.org](http://www.moww.org)), "Companions Only," "Publications."

Shortly thereafter, another convention highlight occurred that was thoroughly enjoyed by all—the MOWW Awards Luncheon—during which the excellence of Companions and chapters were celebrated. Attendees were treated to an exceptional presentation on Federal Bureau of Investigation tactical and rescue operations by FBI Special Agent Kyle Vowinkel (CPT, USA, Former), who is a Companion of the Northern Virginia Chapter.

Next, two important forums occurred, Commanders' Call and Committee Chairs' Call, which were characterized by constructive exchanges on operational matters. The last event of the day was the uplifting Non-Denominational Worship Service, organized and conducted by the Order's superb Chaplain General, LTC Cheryl Brady.

The last day of the convention proper, Saturday, 11 August, began with the traditional ceremony of Companion remembrance, the MOWW Memorial Service, which was also organized and led by Chaplain General LTC Brady. The MOWW Convention (which includes the Business Session and the General Staff Meeting), was well-led by then-CINC Col Gibson. This included annual reports from selected National Officers and committee chairs, votes on proposed amendments to the MOWW Constitution and Bylaws, and ratification of National Officers earlier elected by convention delegates.

The day concluded with the CINC Receiving Line, followed by the final business of the Order—the

CINC Banquet. During the Banquet, then-CINC Col Gibson presented GEN Barry R. McCaffrey, USA (Ret), with the Order's coveted Distinguished Service Award and presented then-SVCINC LTC Hollywood with the prestigious National Commander Award. Following the installation of National Officers, and the Commander-in-Chief change of command, now-IPCINC Col Gibson gave his farewell remarks and CINC-elect LTC Hollywood provided his new commander's remarks (provided in this issue), during which he emphasized, "We are a unique organization," and mentoring will help us remain so.

### POST-CONVENTION (12 August 2018)

This day featured the Post-Convention EXCOM, chaired by CINC LTC Hollywood. He emphasized his CINC priority of enhancing mentoring throughout the Order and the imperative of following-up and following-through on initiatives and issues that may arise or be assigned during the year. ★

## VENEZUELA

The 2016 CIA World Fact Book indicated that the once wealthy democratic nation of Venezuela, now the Bolivarian Socialist nation of Venezuela, had a population of 28,868,486 (2014) of which 93% lived in an urbanized environment. In 2016, the oil-based economy provided for 95% of the government revenue. The poverty line was 31.6% (2011).

Today, much has changed. The nation is in crisis. President Nicolas Maduro, Hugo Chavez's hand-picked successor, has destroyed the nation's economy, its legal and legislative systems, and its governmental functions through dictatorial policies, cronyism, graft and greed. Under Chavez, over a million upper and middle-class people who were the financiers, educated business/professional drivers of the economy left the country. Under Maduro over 2.3 million have fled to other nations since 2014. The brain drain continues as the government is faced with an International Monetary Fund estimate of 1M% inflation, (the government fixed rate for the Bolivar was 6,000,000 to the dollar, now mandated at 60 to the dollar), major electrical blackouts and continuing massive food shortages of all types.

The urban areas are hit the most. The government has taken control of food distribution but has been unable to get agricultural products from the farm to the marketplace. Food imports have dried up due to a lack of money. The WSJ indicated that food shortages have led to an average weight loss of 18 pounds in 2016 and 24 pounds in 2017. The results have been street riots, food distribution favoritism to the military, police and government loyalists, and growth of government militias to control the citizens. Political arrests remain high. Poverty is the norm.

*Petroleos de Venezuela*, developed by US major oil companies in the previous century, was nationalized in 2007. Chavez replaced its management with political loyalists and through the years Chavez used the corporation's preventive maintenance and modernization budget for social programs to

illicit loyalty to his socialist regime. As a result, oil production and resultant exports, the life blood of the economy, has decreased every year since the Bolivarian revolution. In 2012, PdVSA extracted an estimated 2.487 million barrels a day. This July, the International Energy Agency reported the number as 1.2 million barrels a day with a 22% decline since January. Creditors now at the door. ConocoPhillips is in a \$2 billion debt repayment arbitration after a series of Federal court orders permitted it to seize refining and storage facilities in the Caribbean. Crystallex International, a now defunct mining corporation, won a Federal court ruling that permitted it to seize PdVSA's US Citgo Petroleum Corporation to satisfy its \$1.4 billion arbitration award. Venezuela has already defaulted on over \$6 billion in debt owed.

Politically, the country is headed toward anarchy and revolution. The elected National Assembly is outlawed and replaced by a hand-picked legislative organization. The police, military, judicial, and governmental leadership have been compromised by economic favoritism. Opponents are in exile, jail or have been silenced. What is next? One can only surmise it will not be pretty. ★

# MAINTAINING HUMAN CONNECTIONS

In a previous “Chief’s Notes,” I talked about “*inreach*,” i.e., serving each other even as we serve those in our communities. The key to successful inreach is frequent and personal communications—and, as the CINC mentors us, follow-up and follow-through.

So, just what is communications? The simple answer is imparting or exchanging information or news. The most common communication types include interpersonal, nonverbal, written and oral communications. Then we have intrapersonal, interpersonal, group, public and mass communication, which have a different orientation. Or, we have listening, verbal, nonverbal, emotional awareness and written communications. All apply, but the common thread is maintaining human connections.

However we slice and dice communications, in many respects, today’s reality is we increasingly communicate via electrons. We pay our bills, donate and shop online. We get fewer and fewer letters, etc., and instead get emails, internet links and online accounts. We live in an email, text, Twitter and Snapchat world—which, as we know, is fraught with one-sided transmissions, sound-bites, little “listening,” lots of misunderstandings and increasingly disconnected people. Still, habits are strong and we often think that by merely sending emails, we’re communicating or team-building.

Electronic communications—often most of our communications—can be the least disciplined and effective communications. Why? Because these one-way communications distract us from maintaining the human connections necessary to achieve the constructive energy and progress we need.

The article “Nurturing Human Connections,” posted by *Mind Fuel Daily* | *Inspire the Mind, Thought & Wisdom*, argues there are three basic ways of creating and nurturing deep human connections in our lives:

- Be Genuine. We’re humans and when we feel vulnerable, we build walls. Learning to climb over these walls by releasing self-doubt is how we realize our full potential for collegiality, collaboration and companionship.
- Be Kind. Don’t ever think that any one thing you do is meaningless. A single instance of empathy, understanding or help can be enough to change a life. In working with Companions and strangers, realize these moments are what connect us to each other.
- Be Gracious. A powerfully simple way to grow in all our human connections is by remembering the Golden Rule. Be the stranger you want to meet. Be the Companion you want to have. We can find great value in being quick to forgive others, and being even quicker to be a wingman when mentoring or assistance is needed.

Why is this topic important? Because some elements and Companions in our Order feel they’re on their own, struggling by themselves as they deal with the issues they face. We can send all the emails we like, but what makes the difference is frequent and personal communications—a call, a meeting, an abiding relationship—in addition to what the CINC mentors us about follow-up and follow-through.

There is great power in these things because they demonstrate by our attitude and our actions that we’re not in it alone. Instead, we’re part of the Companion team—united in purpose and cohesive in our timely and mutual support. ★



## GET AROUND MUCH?

The fabled “riddle of the Sphinx” is “what walks on four legs in the morning, two legs in the afternoon and three legs in the evening?” The answer is Man. Acknowledging the eventual need for ambulatory assistance is, therefore, at least as old as the pyramids. Today’s information is for your information only, i.e., “just in case.”

While striving for “ambulatory independence,” one needs to get help when and if it’s needed—and that can happen at any age depending on circumstances. While one can pick up an adjustable cane up at the drug store if help is needed, careful thought and planning are needed to get the right device. You really do need professional help to pick correctly.

Reduced mobility is something that many of us do not think about, but a “mobility aid” is what millions of people all over the world live with every day. A mobility aid is a device designed to assist in walking and to improve getting around.

The range of devices goes from various types of canes to scooters and wheel chairs for the sighted and the blind, as well as a multitude of physical conditions. Instability and risk of falling are most common. Wheelchairs or scooters work if an injury or disease has left you unable to walk at all. Knee scooters or lifting chairs are often helpful and stair lifts can be installed inside or outside the home if needed.

Worldwide, 6.1 million people use, canes, crutches and walkers. Osteoarthritis (bone on bone) is by far the most prevalent condition associated prompting the need to use mobility devices. Many factors are involved in determining which device can help: Cognitive function, judgment, vision, vestibular function, upper body strength, physical endurance and living environment.

Canes widen a person’s base of support and provide

increased balance. A cane typically is used when only one upper extremity is required for balance or bearing weight. Canes are helpful in patients who need an additional point of contact with the floor for balance, but who have little or no requirement for upper-extremity weight bearing. Offset canes (long horizontal handles) allow weight to be displaced over the shaft of the cane and can be used for some weight bearing.

Multiple-legged canes (“quads”) provide an increased base of support and permit more weight bearing. Walk canes are broad-based aluminum devices that have a vertical component with a handle and two legs, and another component with two additional legs angled away from the patient. They are ideal for patients requiring continuous weight bearing with only one arm.

Crutches increase the base of support and improve lateral stability. In contrast to canes, crutches can be used for full weight bearing. Axillary (“regular”) crutches are used to provide support to persons with temporarily restricted ambulatory capabilities and keep weight off a foot, ankle, knee or leg. Elbow or forearm crutches are used for patients requiring bilateral upper-extremity support.

Walkers improve balance by increasing the base of support, enhancing stability and supporting the patient’s weight. Standard walkers have four legs with rubber tips that should come into simultaneous contact with the floor. The standard walker is the most stable. Four-wheeled walkers can be used if the patient requires a larger base of support but does not rely on the walker to bear weight. Two-wheeled walkers allow weight bearing and mobility.

All devices can be modified as needed so get a pro to help you. It will be worth the effort.

Willwerth III, USA (Ret), presented the highest award that the Chapter may confer, a Silver Patrick Henry Award, to Special Agent Shaw as CPT William J. Maloney, USA (Fmr), read and presented the accompanying citation.

## Newly Updated Portions of the VA Schedule for Rating Disabilities



Effective 13 Aug, Veterans Affairs (VA) updated portions of the VA Schedule for Rating Disabilities (VASRD, or Rating Schedule) that evaluate conditions related to the skin.

The VASRD is the collection of federal regulations used by Veterans Benefits Administration claims processors to evaluate the severity of disabilities and assign disability ratings.

VA is in the process of updating all 15 body systems of the VASRD to reflect modern medicine more accurately and provide clearer rating decisions.

No conditions were removed from the new skin rating schedule. VA has issued several VASRD updates since September 2017, including updates for dental and oral conditions, conditions related to the endocrine system, gynecological conditions and disorders of the breast and eye conditions. ## VA implements new fiduciary regulations



Veterans Affairs (VA) recently updated regulations related to how it governs the oversight of beneficiaries, who, because of injury, disease, or age, are unable

to manage their VA benefits, and the appointment and oversight of fiduciaries for these vulnerable beneficiaries.

Managed by VA's Veterans Benefits Administration (VBA), the new regulations, which took effect in August, update and reorganize fiduciary rules consistent with current law and VA policies, and clarify the rights of beneficiaries and the roles of VA and fiduciaries in the program. Among other things, the new regulations clarify

beneficiaries' rights, including the right to appeal fiduciary appointments and other fiduciary decisions, the 4 percent limit on fiduciary fees, and the procedures to remove a fiduciary, for instance, when a beneficiary demonstrates the ability to manage their own funds or when VA determines that the fiduciary misused VA benefits. These new rules provide additional protections to veterans and family members

This is the first full revision of the Fiduciary Activities regulations since they were first published in 1975.

## Accolades for Fort Bliss National Cemetery



The Department of Veterans Affairs has named Fort Bliss National Cemetery (El Paso, TX) as an Organization of Excellence, a designation that is given to national

cemeteries that meet strict department standards. Across the 82 plus acre site, there are more than 50,000 graves, including one that is the final resting place of the post's namesake, Lieutenant Colonel William Wallace Smith Bliss.

According to the National Cemetery Administration, of the monuments and memorials located within the grounds of the cemetery, one is from The Military Order of the World Wars. The granite monument was dedicated in 1986 to all Officers in military service.

Other memorials or monuments located there are from the Pearl Harbor Survivors Association; the American Prisoners of War; The Military Order of the Purple Heart; The El Paso Del Norte Chapter, Gold Star Wives of America and The Korean War Veterans Association.

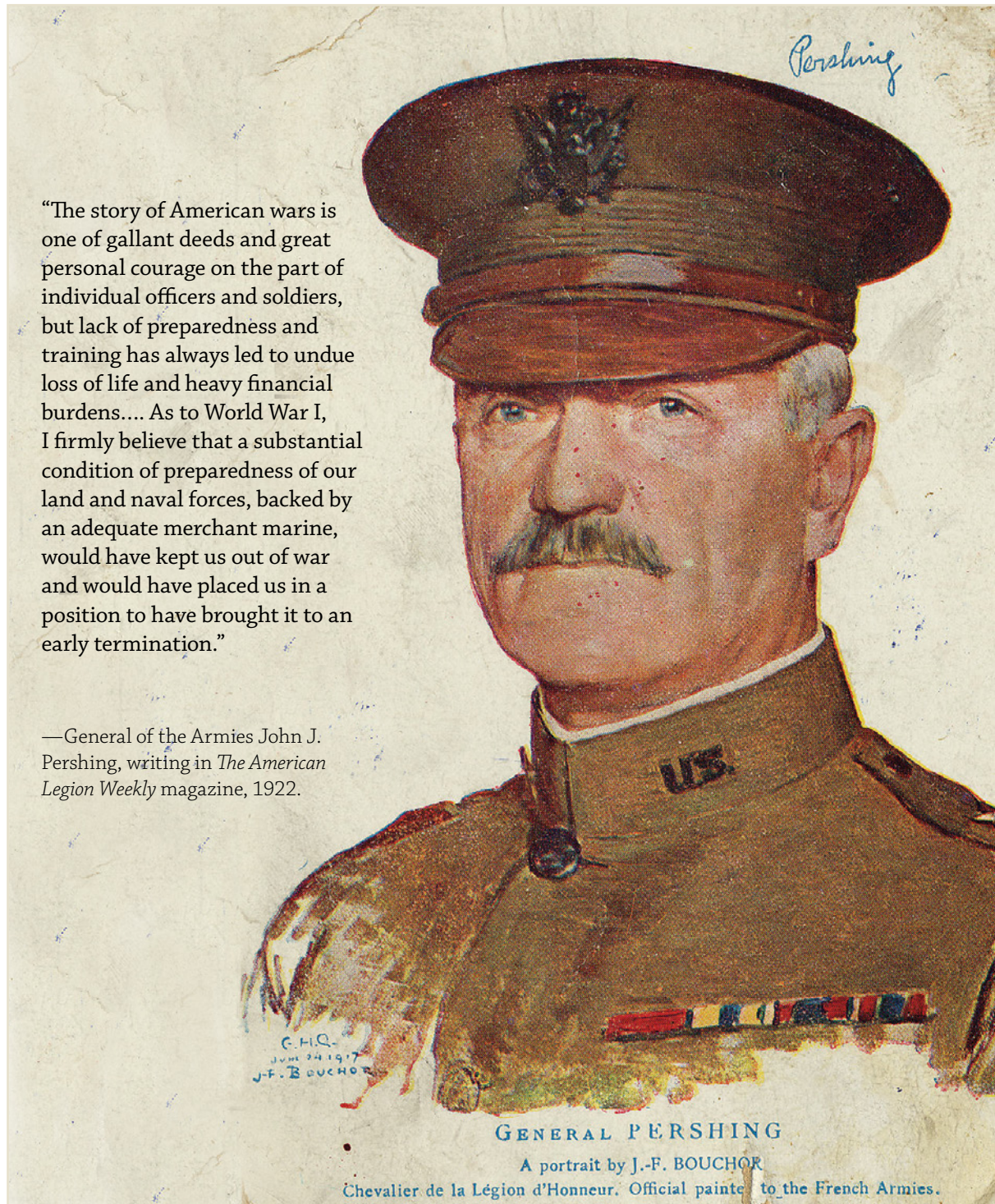

The Military Order of the World Wars is a non-profit Veterans Service Organization (VSO) composed of US Federally-recognized commissioned officers and warrant officers who are citizens of the United States of good moral character and repute who are serving or have served honorably in the Active, Reserve, or National Guard of the United States Army, Navy, Air Force, Marine Corps or Coast Guard, the National Oceanic and Atmospheric Administration (NOAA) Corps and/or the United States Public Health Service (USPHS) Corps. Membership eligibility is also extended to descendants and spouses of these officers, and US Service Academy cadets. Eligible individuals may join one of the Order's chapters located throughout the United States or National Headquarters Chapter.
