Commander-in-Chief's Intent (OY 2024)



As the 93rd Commander-in-Chief (CINC) of the Order, my intent is to continue modernizing our Order and establish ourselves as an attractive Veterans Service Organization (VSO) with a clearly defined public image that we are "Serving Youth, Community, and Nation." Our efforts need to be centered around five essential priorities that are critical to our modernizing effort:

a. Our Order's Preamble: The Preamble to the MOWW Constitution not only is the cornerstone of our Order but artfully articulates the Order's core values, values that are reflected in the efforts of all our Companions who collectively emulate our motto that "It Is Nobler to Serve Than To Be Served." The Preamble needs to be central in every Companion's effort: we need to know it, embrace it, articulate it, and promote it. This critical focus by each and every one of us will attract new members who believe in what we stand for, in turn resulting in their better understanding and the embracing of our Order's rich heritage, which serves as a backdrop to our community outreach efforts.

b. The Order's Financial Health: A top-to-bottom review of our financial models is required if our Order is to maintain long-term sustainability. Deficit spending coupled with the need for required short and long-term financial investments to modernize the Order (and thus extend our community outreach footprint) requires a thorough analysis of the Order's overall financial strategy. A synergistic approach between the EXCOM, Finance Committee, the MOWW Foundation, and the Board of Trustees is essential to this review.

c. MOWW 2023-2028 Strategic Plan: Our plan outlines the Order's short and long-term goals and associated objectives. As the plan states, "Every component at every level of the Order is expected to make these goals the focus of its core agenda." Annex B of the plan identifies metrics that not only measure goal attainment but provide a detailed roadmap for all echelons of the Order to follow as we continue to move our Order forward and, in turn, ensure viable and sustainable Community Outreach programs for generations to come. Each VCINC, each Region Commander, each Committee Chair, each Department Commander, and each Chapter Commander is being asked to make our strategic plan an operational priority and to craft short-term and long-term accountable action plans that will move our order forward, built upon a mindset of "Making Things Happen" in the spirit of those in the Order that have gone before us over the last 105 years of our rich heritage.

d. Patriotic Education. "To promote and further Patriotic Education in our nation ..." Our Order's Patriotic Education program sets us apart from all other VSOs and needs to be our flagship community outreach program. The program as it currently exists requires a thorough top-to-bottom review as we search for additional ways to reach out to our youth beyond Youth Leadership Conferences and Seminars, recognizing top ROTC/JROTC cadets, and those who have excelled in Scouting. Character development programs and resources, enhanced civics education, as well as increased mentoring opportunities, and sponsoring of youth service projects, all need to become an integral part of a comprehensive program.

e. America250. "America250 is a national, nonpartisan initiative working to engage every American in commemorating the 250th anniversary of our country." The embracing by our Order of the America250 initiative parallels the efforts of the America250 co-chairs who are "charged with ensuring recognition of the sacrifice of our service members and their families. To honor their contributions, these co-chairs center our discussion on the value of service, as well as supporting the families of the larger military and American community." MOWW is a perfect fit to become part of America250, and in turn, America250 can serve as a catalyst for each of our Companions' efforts within our communities. Additionally, a MOWW *America250 Ad Hoc Committee* will have a two-year charter to conduct a review and study of our Order's overall structure and programs, working hand-in-hand with our Strategic Growth and Strategic Planning Committees as we continue our modernization efforts, and will make recommendations as appropriate to the EXCOM. The ad hoc committee members will comprise a team of dedicated Companions throughout the Order, including Companions serving at the Chapter, Region, and National levels. 2. In 2021, the Order embarked on what has been a steep three-year vertical climb towards modernization and brand recognition, resulting in an expanded community outreach footprint: over the coming years, we must continue these efforts if the Order is to grow and thrive in our communities for decades to come. In short, we must continue to look at "What Are We Doing and Why Are We Doing It?" I believe our glass is "Half-Full" and not "Half-Empty," and I am confident that with the assistance of all Companions working together as a team, these positive efforts will continue to move our Order forward.

2024 CINC'S BANQUET 93rd COMMANDER IN CHIEF REMARKS

My Fellow Companions, I would like to start off by saying that as your 93rd Commander In Chief of the Order, I pledge to continue modernizing our Order and establishing ourselves as an attractive Veterans Service Organization (VSO) with a clearly defined public image that we are "Serving Youth, Community and Nation."

In this, the 105th year of the Order, we pause to reflect upon our rich heritage dating back to World War I. After the "Great War" was over, General John J. "Blackjack" Pershing, in a personal letter to his soldiers, stated: "In leaving the scenes of your victories, may I ask that you carry home your high ideals and continue to live as you have served—in honor to the principles for which you fought and to the fallen comrades you leave behind." In 1919, the American Officers of the World War was founded by those who served under General Pershing. This organization changed its name to the Military Order of the World War and, after World War II,



to the name of our Order as we know it today. Our Order has proudly bestowed the title of Honorary Commander In Chief 13 times on leaders such as General Pershing, General George C. Marshall, Jr., and General Omar N. Bradley, and no less than five US Presidents to include Dwight D. Eisenhower, Ronald Reagan, and George H.W. Bush. Our Order has more than a legacy; it is a respected Veterans Service Organization that is recognized at national events and one of the few that is chartered by Congress; consequently, it is the duty of each and every Companion to preserve our Order's legacy, and make that legacy a central theme that binds us together.

Which brings me to our beloved Preamble to the Constitution of the Military Order of the World Wars, and the author of that Preamble, a World War I veteran, Captain Francis "Frank" Bartholomew Grevemberg, Jr. Captain Grevemberg served in the 312th Regiment of Engineers, 87th Division, stationed at Camp Pike, Arkansas, in September 1917. After extensive training, the 312th Engineers arrived in France on September 12, 1918,



two months before the signing of the Armistice. Two years later, in September of 1920, Captain Grevemberg had two days of train travel en route to the first convention of the American Officers of the Great War, and it was during this train ride that Captain Grevemberg authored the Preamble, the same Preamble we recite today.

So that brings me to the first of five essential priorities that our efforts need to center around, which are critical to our modernizing effort:

1. Our Order's Preamble: Our Preamble is not only the cornerstone of our Order, but Captain Grevemberg artfully defined the Order's Core Values. These values are reflected in the efforts of all our Companions who collectively emulate our motto that "It Is Nobler To Serve Than To Be Served." The Preamble needs to be central in each and every Companion's effort: we need to know it, embrace it, articulate it, and promote it. This critical focus will attract new members who believe in what we stand for, in turn resulting in their better understanding and the embracing of our Order's rich heritage which serves as a backdrop to our community outreach efforts.

2. The Order's Financial Health: Second, a topto-bottom review of our financial models is required if our Order is to maintain long-term sustainability. Deficit spending, coupled with the need for required short and long-term financial investments to modernize the Order (and thus extend our community outreach footprint), requires a thorough analysis of the Order's overall financial strategy. A synergistic approach between the EXCOM, Finance Committee, the MOWW Foundation, and the Board of Trustees is essential to this review.

3. MOWW 2023-2028 Strategic Plan: Our MOWW 2023-2028 Strategic Plan outlines the Order's short and long-term goals and associated objectives. As the plan states, "Every Companion at every level of the Order is expected to make these goals the focus of its core agenda." Annex B of the plan identifies metrics that not only measure goal attainment but provide a detailed roadmap for all echelons of the Order to follow as we continue to move our Order forward and, in turn, ensure viable and sustainable community outreach programs for generations to come. Every VCINC, Region Commander, Committee Chair, Department Commander, and Chapter Commander is expected to prioritize our strategic plan and develop specific short and long-term action plans. These plans should be accountable and aimed at advancing our Order. Our approach should be rooted in the mindset of "making things happen" to pay homage to the legacy of those who have paved the way over the past 105 years.

4. Patriotic Education. This brings me to my fourth priority, my passion, our Patriotic Education

Program, specifically as stated in our Preamble: "To promote and further Patriotic Education in our Nation." Our Order's Patriotic Education Program sets us apart from all other VSOs and absolutely needs to be our flagship community outreach program.

Shortly after the tragic events of 9-11, our 43rd President, George W. Bush, sent our then 71st Commander-in-Chief, First Lieutenant Donald G. Allen. This letter is posted at our Headquarters Building in Alexandria, Virginia. Please allow me to read from the letter:

"As we engage in our current campaign to fight the forces of terror on the global battlefield, I commend the Military Order of the World Wars and your mission to help our nation's young people better understand the value of freedom.

America's young people should have the opportunity to learn from the men and women who have been on the

front lines, who have stood firm in the face of combat, and pressed on against the odds to achieve victory for liberty's sake. Our young people need to appreciate the meaning of our founding documents. They must be confident in the words of our Declaration of Independence, our Constitution, and the Bill of Rights, and they should know why 25 million living veterans are willing to give the last full measure of devotion to preserve our American way of life.

The Military Order of the World Wars helps strengthen our nation by teaching our young men and women that patriotism is a virtue and that America is a land made richer by our Patriots' noble sacrifices."

I cannot say it any better than that. Tonight, I am asking our Patriotic Education Committee to conduct a thorough top-to-bottom review as we search for additional ways to reach out to our youth well beyond our effective youth leadership conferences and seminars, recognizing top ROTC and JROTC cadets and

honoring those who have excelled in Scouting. Character development programs and resources, enhanced civics education, increased mentoring opportunities, and the sponsorship of youth service projects must become an integral part of a comprehensive program. It is essential that our Order's Patriotic Education Program also promotes existing youth programs, such as the Medal of Honor Character Development Program and the Wreaths Across America Youth Service Project, as well as partnering with those organizations that sponsor and promote Youth Leadership and Character Development Programs throughout their communities, many of whom we heard from during this convention. This is the community outreach focus, in addition to supporting and recognizing our fellow veterans past and present, that will give our Order a clearly defined outreach focus and an established Veterans Service Organization identity. In the words of President Ronald Reagan, "We are just one generation away from extinction ..." and we need to continue carrying the torch of Patriotic Education to ensure that our youth understand their role in the future of our great nation.

Tonight, I dedicate our Patriotic Education efforts to a great man, one who inspired me and to whom I looked up, Sergeant Jimmy Weldon. A true friend, Jimmy, passed away last year just two months short of his 100th birthday. During World War Two, Sergeant Weldon distinguished himself as a combat engineer for the Third Army under the direction of General George S. Patton, Jr., constructing key pontoon bridges and clearing enemy minefields following the Allied invasion of Normandy in June 1944. After serving in the Battle of the Bulge, Sergeant Weldon's squad then liberated the Buchenwald Concentration Camp. In recent decades, through his project, The Center for Youth Patriotism, Sergeant Jimmy Weldon instilled in California's youth a sense of civic, nonpartisan pride and a better understanding of our shared heritage through the use of audio/visual programs and personal presentations. Nobody loved the American flag more than Jimmy, and his rendition of what the American flag represents, entitled I Am The Flag, can be viewed on YouTube. I encourage every one of you to view that video, a video that needs to be shown to our youth by local chapters and at YLCs and YLSs throughout the country. We all need to carry the torch of Patriotic Education as Jimmy did and in the spirit,

as General Pershing and Captain Grevemberg intended.

5. America250. Last but certainly not least, we are approaching the 250th anniversary celebration of our country, the signing of our treasured Declaration of Independence on July 4, 1776. "America250 is a national, nonpartisan initiative working to engage every American in commemorating the 250th anniversary of our country ... " The Order's adoption of the America250 initiative mirrors the efforts of the America250 co-chairs, retired Army Major General Alfred Valenzuela and retired Army Major General Peggy Combs, representing the Veterans, Military, and Family Members Advisory Council. These two outstanding leaders are "charged with ensuring recognition of the sacrifice of our service members and their families. To honor their contributions ... these co-chairs center (the national) discussion on the value of service and supporting the families of the larger Military and American community." Furthermore, the goals of the co-chairs include empowering and energizing VSOs currently serving across the country: MOWW is a perfect fit to become part of America250, and in turn, America250 can serve as a catalyst for each of our Companions' efforts within our communities.

Additionally, the MOWW America250 *Ad Hoc* Committee will have a two-year charter to conduct a comprehensive review and study of our Order's overall structure and programs, working hand-in-hand with our Strategic Growth and Strategic Planning Committees as we continue our modernization efforts, and will make recommendations as appropriate to the EXCOM. The ad hoc committee members will consist of a team of dedicated Companions throughout the Order to include Companions serving at the Chapter, Region, and National levels.

America250 will also be the theme of next year's MOWW convention in Tucson, AZ. We must actively promote the Order's engagement in America250--online, across all our social media platforms, national and chapter websites, as well as during chapter meetings and in national publications. Chapter Action Plans should reflect America250 initiatives paralleling their overall operations effort and be part of a mindset of not only a celebration of our nation's heritage but of the recognition and promotion of our Order's heritage of Companions' service to our country both during and after military service.

On November 19, 1863, our 16th president of the United States, Abraham Lincoln, gave his famous 267-word address at the site of one of the bloodiest vet decisive battles of the Civil War. The purpose of the Gettysburg Address was to dedicate the battlefield to the fallen and serve as a catalyst for the national cemetery system we have today. It is fitting that at each of these 155 national cemeteries, you will find posted Abraham Lincoln's entire Gettysburg Address; it will be equally fitting that in line with what's stated in our Preamble to "Encourage and assist in the establishing of memorials of the World Wars" that there should be a MOWW monument at each of these cemeteries, and as part of our America250 initiative we embark on a five-year plan to fulfill this mission, to include use of our Gist Blair Fund that was established as a testamentary trust fund to finance certain limited and specified historical purposes for the benefit of the Order.

To conclude, in 2021, the Order embarked on what has been a steep three-year vertical climb towards modernization and brand recognition, resulting in an expanded community outreach footprint: over the comings years we must continue these efforts if the Order is to grow and thrive in our communities for decades to come. Along those lines, I would like to close with these thoughts: as we look upon the American Flag, please remember that the Star Spangled Banner, which many of our comrades died for, speaks to us each and every day: "I am the flag that stands for the greatest nation on earth. I am no more than what you believe me to be, and I am all that you believe I can be. I am what you make me and nothing more. And as long as men cherish liberty more than life itself, I shall continue to be the enduring banner of the United States of America."

Ladies and gentlemen, look at our Flag with renewed allegiance, continue to honor her, always respect her, and as those of us in this room and our fallen comrades have done, defend her! ★

Building a Memorial That Honors All

Michael Rodríguez is many things. He is a former Green Beret, a Somalia, Haiti, Global War on Terrorism veteran, an artist working with metal, a military father, and the President and CEO of the Global War on Terrorism (GWOT) Memorial Foundation, the nonprofit organization designated by Congress to plan, fund, and build the National Global War on Terrorism Memorial.

"Leading the construction of a Memorial that will honor all who served and sacrificed in this conflict is an undeserved honor and my life's mission," says Rodríguez. "We are well underway in the process of constructing the most inclusive war Memorial in history."

After retiring from the US military due to injuries sustained in combat, Rodríguez was passionate about honoring the service of all who have participated in the Global War on Terrorism—uniformed and nonuniformed personnel, as well as their families. In 2016, he was invited to serve on the board of directors of the GWOT Memorial Foundation. He supported the 1-year-old Foundation alongside a passionate group of likeminded veterans, military spouses, and supportive Americans.

Says Rodríguez: "Given the incredibly complex and difficult-to-define war's significance to American history in the 21st century, it is our shared duty to provide the millions of veterans and their families a place on the National Mall in Washington, DC, to honor, heal, be empowered, and unite around those still serving."

It may come as a surprise to many Americans, including veterans, that such an effort is underway. However, since its formation in 2015, the Foundation has continued to achieve steady progress toward a ribbon cutting. The journey is not without obstacles. Constructing a Memorial on the National Mall requires navigating a federally mandated 24-step process, including authorizations from Congress and multiple federal agencies.

"After we received our initial authorization to build the GWOT Memorial from Congress in 2017, I stepped into the leadership position and inquired about building our Memorial on the National Mall in the Reserve. This location has not seen any new authorizations since 2003. Nearly everyone told me that it was impossible and it'd never happen," says Rodríguez. "But we kept working on what we knew was right, approaching our mission with the sanctity and reverence it deserves. In 2021, after years of effort, we secured bipartisan congressional approval for the Memorial to be in the Reserve portion of the National Mall-alongside America's other War Memorials. Now we are in steps 13-19 of the process!"

Crucially, says Rodríguez, Americans must remember that the Global War on Terrorism carries on, and Americans continue to answer the call of duty to fight terrorism to this day. "Although this multigenerational war is unlikely to be the top story on your evening news, thousands of our country's men and women are protecting our security and freedom from terrorism every day. We must not forget them."

In September 2023, the Foundation unveiled the "Help Design History" campaign, upholding its commitment to ensuring that the Memorial's design encompasses diverse experiences from the Global War on Terrorism. This nationwide survey gave those with personal experiences and those who supported them in the Global War on Terrorism a voice in the Memorial's design. People from all 50 states, members of every military branch, and veterans of every war since World War II completed the survey. The Foundation has also established a <u>Design Advisory</u> <u>Council</u> comprising Gold Star family members, veterans, and active-duty service members. They will be crucial in influencing the design.

"This first-of-its-kind approach ensures the Memorial reflects the range of service and the volume of sacrifices in the Global War on Terrorism, thereby telling the story of the countless Americans who have stepped forward to serve us all," says Rodríguez.

Don't Drown in Shallow Waters

The following is from this year's MOWW Non-Denominational Worship Service Convention.

The scripture is Acts, Chapter 27: 42-44: The soldiers planned to kill the prisoners to prevent any of them from swimming away and escaping. But the centurion wanted to spare Paul's life and kept them from conducting their plan

Do you ever feel like you are struggling with something vou should be able to manage? Do you feel you are close but can't quite cross the finish line? Paul offers insight into how to perceive and tackle the inevitable trials in our lives. We often get hung up on the illusion that everything would be fine if God were with us. The truth, however, is that the presence of storms does not "indicate the absence of God." It is during these storms that God has his angels surrounding us and is with us.



when you enter a storm, you might encounter various combined storms: physical, financial, and emotional. What is our storm in MOWW? If you attended the current MOWW Chief of Staff briefing, you learned about a massive storm that is brewing and about to hit land. What personal storms are we experiencing as Chapters or as Companions?

Point Two: God resides in Trouble. God did not promise to make you

It can be hard to see in a storm—your trial may seem like a torrential downpour—but rather than focusing on what you can or cannot see, focus on your faith. The New Testament reminds us that "God is that "help in trouble." Psalm 46:1: "God is our refuge and strength, an ever-present help during trouble." Today, we are grappling with numerous challenges in our personal lives, government, youth, and the increasing disregard for societal norms.

When we face trouble or difficulties, we can turn to God for help. He is our refuge and strength, always present and ready to provide the help we need. In times of hardship, we can find comfort and strength in knowing that God is with us, offering His assistance and support.

Point one: Don't mistake the storm's presence for the absence of God. Consider that sometimes, comfortable in your storm. Just because you are in the presence of the storm, the storm does not negate the presence of God, nor does it indicate the absence of God. In fact, if you really want to see God do his best work—get in trouble. Anytime God promises you something, get ready for trouble.

In 1952, Florence Chadwick attempted to swim the channel between the coast of California and the island of Catalina. The distance is twenty-six miles. At the 15-hour mark, a thick fog enveloped her, obscuring the shoreline and her intended direction. With her goal out of sight, she also lost her way as the mist clouded her judgment. After covering twenty-five miles, she decided to quit and boarded her safety boat just one mile short of her goal. When we think we do not see God, we give up. God is always with us through the storm and fog.

Companions, what can we do to show others our relationship and faith with God and that we will not drown in shallow water! ★

At the Virginia Tech Corps of Cadets Spring Awards Ceremony in April, ten cadets were presented the MOWW ROTC Medal of Merit by the Roanoke Chapter of MOWW. As one of the esteemed six Senior Military Colleges in our nation, cadets have the opportunity to earn commissions from the Army ROTC, Naval ROTC (which includes the Marine Corps) and Air Force ROTC (which includes Space Force). He and his wife, Kathy, have chosen to establish their residence in the vicinity of College Station, TX, in order to be in closer proximity to their son, Steve.


